Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to thewrapagency.com, and Clean Slate Group dba The Wrap Agency and governs data collection and usage. The Wrap Agency website is an informational site. By using the Wrap Agency website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Wrap Agency may collect personally identifiable information, such as your:

- First and Last Name
- Email Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services.
